Maybe they'll also be motivated to join some of these lighthouse societies and help out with lighthouse preparation. (I am a member of the Pointe aux Barques Lighthouse Society and the Alcona Historical Society, which is working to preserve the Sturgeon Point Lighthouse.)

Here's a mockup that I came up with this morning. It's derived from a State of Michigan lighthouse map. Each lighthouse is numbered, and I plan to put the list on the back of the certificate. (If you have some skill at graphic design, and would like to help out with this award, please get in touch.)



To qualify for the award, you'd have to make at least five contacts from at least five different Michigan ARLHS lighthouse sites. I'm thinking that there will be a PDF version that can be downloaded from this website, and if someone wanted a printed version, then there will be small charge for printing and mailing.

To be honest, I don't qualify for the award yet, myself. I have only activated four different lighthouses, including the Pointe aux Barques Lighthouse, Lightship Huron, Tawas Point Lighthouse, and the Sturgeon Point Lighthouse. I plan to visit the Belle Isle Lighthouse, which is actually the closest one to me here in Ann Arbor, before the summer is over.

Let me know if you have any interest in this award, especially if you already qualify for it. I'm going to go ahead with this one way or another.

Hams Radio Operators Support American Red Cross in Kentucky Flood Response

As the flood waters began to recede following devastating rainfall in Kentucky that began on July 26, the American Red Cross reported that over 400 of their disaster workers were on the ground, as well as dozens more in other locations. They provided shelter, meals, and other forms of support. Red Cross teams also worked alongside their state and municipal partners among others, including Kentucky Amateur Radio Emergency Service® (ARES®) volunteers.

ARRL Director of Emergency Management Josh Johnston, KE5MHV, was in touch with American Red Cross personnel in the affected area. He said ham radio volunteers were supporting Red Cross damage assessment teams with radio communications. "The rural and mountainous terrain of the affected area adds to the already difficult situation," said Johnston.

Much of the local response effort is being coordinated by Steve Morgan, W4NHO, of Owensboro, Kentucky. The response of radio amateurs throughout the region is under and in cooperation with an existing Memorandum of Understanding (MOU) with the Kentucky Chapter of the American Red Cross.

ARES® groups from Ohio and Virginia have also been in touch with hams in the affected areas and have been on standby, ready to respond if needed.

COMMITTEE REPORTS:

- Hamfest Kalamazoo Hamfest is Oct 16th (Sunday) 8:00AM-Noon. SMARS members are invited to help out.
- Skywarn/CERT Report from Bret KD8RHB CERT assisted at the June breakfast table event. There was one call for medical assistance for an attendee. also helped out at the balloon festival as rovers, backup support for event staff and the fireworks show. This was the first time they helped with the "show-box" for the Thunderbirds' air show (Friday, Sat., Sunday, and Monday). Bret ran two simultaneous nets. Spotters had to check in with any rail movement coming in from Eaton, Kalamazoo, and Calhoun Counties toward the airport. Information was then forwarded to the FAA.

CERT communications volunteers are needed for the Calhoun County Fair. The next CERT class will be held in September 16 (6-10pm), 17 (9am-5pm), and 24th (9am-5pm) at the Public Works Dept on Kendall and is open to anybody. The 5th District exercise will be at the end of September and a CORES exercise (next week Thursday?) The mode for CORES has not yet been determined.

Four warning sirens in Calhoun County are not working (including the I-94 rest stop siren). RadioComm had previously serviced this siren but they are unable to at this time. Bret has contacted vendor West Shore to service these sirens. Emmett Township is investigating putting up two sirens. Bret was in 9:00 AM board meeting for interoperability. WinLink will be used for the 5th District exercise.

SMART 911/RAVES was recently rolled out (replaces Nixel). A ham-in-a-day (HIAD) session is being planned for October 15th (Saturday) at the Battle Creek Police Dept. Bret recently got his SHARES license (FEMA).

 Field Day 2022 – Kyle W8KDB, Dan WB8KC, Kelly KE8MWQ, and Paul KE8MOI stayed overnight Saturday. Kudos to Kyle for his guidance with setup. Kelly got her 1st HF contact. A lot of contacts were made via PSK31. Many thanks to Players Club for catering Saturday's

- dinner. Per Kyle, our total score was 2,050 points (generator, public information, public location, daily message, elected official visited the site, educational activities, social media): 125 digital (x2 multiplier) and 250 by phone. They are doing aggregate scores. Persons who participated via their home station can submit their contact data to "SouthernMIARS" to be included with SMARS' club score. Some equipment will need to be repaired/serviced before next Field Day (Butternut antenna, one mast is difficult to crank up).
- VE Session Nest session is Thursday, Aug 25th. Kyle mentioned the ARRL article about the replacement of the CORES system. He recommended everyone move their CORES account over to the new system sooner than later.
- Repeaters Don W8RVT had nothing to report.

OLD BUSINESS:

- Tom W. KE8GDN He has organized four Foxhunts this year. Additional foxhunts will be postponed until later this fall.
- Trailers have been pulled by the barns at his QTH.
 He sprayed the tops of the trailers with Flex Seal.
 There is a leak in trailer #3 (HF) near the vent and
 some surface rust. Tom asked if the club wanted to
 pursue RV Roof Seal (white elastomeric with
 reflective material). Pros are that it would keep the
 trailers cooler and it would be easier to patch. We
 would likely need 5 gallons of each. The trailers
 would need to be cleaned prior to applying the RV
 sealant.
- Dan WB8KC and Jay N8ARR suggested that the club consider allocating money to purchase RV sealant for all three trailers. The board will discuss it at the next meeting. Jay N8ARR volunteered some funds to cover some of the cost of the RV sealant.
- Tom W. asked for ideas for programs for the next couple of months. Bret KD8RHB will do a WinLink presentation at the September meeting.

NEW BUSINESS:

- KQ8N Mike reported an error in the Feedback. He had actually offered to cover the VE room fees, not pay for individual exam fees.
- Paul KE8MOI would like to put one of the club trailers in the BC Holiday Parade. There is no entry fee for the parade. He suggested that the club print off cards to hand out with the club's information.
