# Some New Rules Going into Effect this Year for ARRL Field Day

After taking a few detours over the past couple of years due to the COVID-19 pandemic, <u>ARRL Field Day</u> rules are being updated on a permanent basis starting this summer. ARRL conducted a Field Day community survey with invitations propagated far and wide, and direct emails sent to more than 15,000 individuals and ARRL-affiliated clubs. After sorting through, reviewing, and discussing the survey results, the ARRL Programs and Services Committee recommended a number of rule changes for ARRL Field Day, which will take place this year over the June 25 – 26 weekend.

Starting this year, the maximum PEP output for a transmitter used by anyone submitting a Field Day log will be 100 W. The power multiplier of 2 will remain in place, and the high-power category will be removed from the rules. Until this year, the maximum low-power limit had been 150 W for most ARRL-sponsored operating events. The power multiplier will remain at 5 for QRP participants running a maximum of 5 W or less. As previously announced, 100 W is now the low-power category limit for all ARRL and IARU HF Contests, effective January 1, 2022.

A couple of changes instituted initially as accommodations for the COVID-19 pandemic will remain. Class D (Home) stations will continue to be able to earn points for contacts with other Class D stations. The club aggregate scoring change initiated in 2020 as a temporary measure will become part of the permanent rules. In the aggregate scoring plan, the scores of individual stations are combined under the score of a single club.

Another change, involving Rule 7.3.2 Media Publicity, has been modified. Rules to date have offered 100 bonus points for attempting to obtain publicity and demonstrating same. With the ease of posting via Facebook, Twitter, Instagram, and various other media websites, Field Day participants will now be required to obtain publicity, not just try to do so. Any combination of bona fide media hits would qualify for the bonus points. For example, posting the details of your upcoming or ongoing Field Day activity, or your Field Day results, on a club or news media site, on Facebook, or via Twitter and Instagram would meet the bonus criteria. Photos and videos are encouraged as part of media posts.

**Treasurer's report:** Motion made to accept the report as passed around at the club meeting. Motion passed.

#### **COMMITTEE REPORTS:**

- Hamfest Jay N8ARR brought in the tickets (yellow). He contacted Livonia ARC to see if they would put out fliers at their Hamfest and is awaiting word back. Per Paul KE8MOI, Tom WR8G has the schematic for the table setup and is willing to help with setup arrangement. Tom WR8G has provided a list of prior vendors and their contact information to Terry N8LN and Paul KE8MOI. They will be sending out an email blast to these vendors this weekend. Paul talked with Cheryl Pickett @ Wings Stadium. Things are still a "go" for now, however, she said that (depending on COVID) there is the possibility that the event might be canceled.
  - The ARRL posting for our Hamfest was missing. Kyle W8KDB followed up with the ARRL which responded that our application for sanctioning was lost. Smokey resubmitted the application to the ARRL and confirmation was received from the ARRL granting their approval for sanctioning. A table will be provided for ARRL representatives free of charge. SMARS will hold a VE session at the Hamfest.
- AUXCOMM/Skywarn Report Calhoun EC Bret KD8RHB has put together a newsletter for WX8BTL BC Skywarn/Auxcomm. There was a good turnout of members at the Tuesday night meeting. Chris Young, new Emergency Services Director, was introduced. Urbandale school siren did not work at the January siren test. Cause appeared to be an error on the power meter at the site. The siren at Avenue A and Dickman Road also did not function. The vendor (Westshore) will need to send out a technician. They are hoping to get this siren back online by March.

FEMA Region 5 exercise - Operation High Water - is planned for the end of July, exact date and time is vet to be determined.

Auxcomm exercise is scheduled for April 30th, focused on WinLink. All districts in Michigan and possibly Illinois will be involved. US Forest Service is charging a fee for repeaters. This Saturday, January 22, will be a virtual "storm chasers summit" chasersummit.com. Cost: \$60. D-Star simplex (145.000 MHz) will be used for check-ins at next Tuesday's net. VHF simplex exercise "Winter heat" is going on this month. This is third year it's been held. Go to Hamactive.com for more information.

- Winter Field Day Scheduled for Jan. 29th-Jan. 39th (starts at 2 PM, runs for 24 hours). Set up at Uncle Larry's (15596 15 Mile Road, just off Verona Road), 9:30 AM on Jan 29th. Will have a heated trailer (county's emergency operation center), operating station operating (1-I class). Operating from home is 1-H. Additional points are awarded for emergency power. Callsign will be AB8I (Scott's). Highlight last year was a contact made with a station in Antarctica! Everyone is welcome to stop in.
