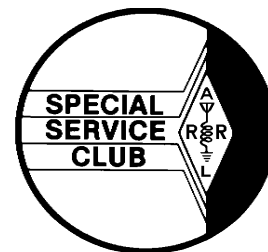

## **WE WILL NEVER SEE THIS HAPPEN AGAIN..... BUT THIS IS THE WAY IT SHOULD BE....**

Harry Truman was a different kind of President. He probably made as many, or more important decisions regarding our nation's history as any of the other 42 Presidents preceding him. However, a measure of his greatness may rest on what he did after he left the White House.

The only asset he had when he died was the house he lived in, which was in Independence, Missouri. His wife had inherited the house from her mother and father, and other than their years in the White House, they lived their entire lives there.

When he retired from office in 1952, his income was a U.S. Army pension reported to have been \$13,507.72 a year. Congress, noting that he was paying for his stamps and personally licking them, granted him an 'allowance' and, later, a retroactive pension of \$25,000 per year.

After President Eisenhower was inaugurated, Harry and Bess drove home to Missouri by themselves. There was no Secret Service following them.

When offered corporate positions at large salaries, he declined, stating, "You don't want me. You want the office of the President, and that doesn't belong to me. It belongs to the American people and it's not for sale."

Even later, on May 6, 1971, when Congress was preparing to award him the Medal of Honor on his 87th birthday, he refused to accept it, writing, "I don't consider that I have done anything which should be the reason for any award, Congressional or otherwise."

As president he paid for all of his own travel expenses and food.

Modern politicians have found a new level of success in cashing in on the Presidency, resulting in untold wealth. Today, many in Congress also have found a way to become quite wealthy while enjoying the fruits of their offices. Political offices are now for sale. (e.g. Illinois)

Good old Harry Truman was correct when he observed, "My choices in life were either to be a piano player in a whore house or a politician. And to tell the truth, there's hardly any difference!

I say dig him up and clone him!!

## INTERESTING

Have you ever wondered what happened to the 56 men who signed the Declaration of Independence?

Makes one stop and think of the caliber of these men compared to what we have today in our government.

Five signers were captured by the British as traitors, and tortured before they died.

Twelve had their homes ransacked and burned. Two lost their sons serving in the Revolutionary Army; another had two sons captured.

Nine of the 56 fought and died from wounds or hardships of the Revolutionary War.

They signed and they pledged their lives, their fortunes, and their sacred honor.

What kind of men were they?

Twenty-four were lawyers and jurists. Eleven were merchants, nine were farmers and large plantation owners; men of means, well educated, but they signed the Declaration of Independence knowing full well that the penalty would be death if they were captured.

Carter Braxton of Virginia, a wealthy planter and trader, saw his ships swept from the seas by the British Navy. He sold his home and properties to pay his debts, and died in rags.

Thomas McKean was so hounded by the British that he was forced to move his family almost constantly. He served in the Congress without pay, and his family was kept in hiding. His possessions were taken from him, and poverty was his reward.

Vandals or soldiers looted the properties of Dillery, Hall, Clymer, Walton, Gwinnett, Heyward, Rutledge, and Middleton.

At the battle of Yorktown, Thomas Nelson, Jr., noted that the British General Cornwallis had taken over the Nelson home for his headquarters. He quietly urged General George Washington to open fire. The home was destroyed, and Nelson died bankrupt.

Francis Lewis had his home and properties destroyed. The enemy jailed his wife, and she died within a few months.

John Hart was driven from his wife's bedside as she was dying. Their 13 children fled for their lives. His fields and his gristmill were laid to waste. For more than a year he lived in forests and caves, returning home to find his wife dead and his children vanished. So, take a few minutes while enjoying your 4th of July holiday and silently thank these patriots. It's not much to ask for the price they paid.

### Ohio State Parks On the Air

The day is Saturday and the time is from 12 noon to 8 PM -- 1600Z August 28 to 0400Z August 29. The object is to set up portable amateur stations in as many Ohio State Parks as possible and for stations not at parks to work as many park stations as they can.

Ohio and non-Ohio amateurs can compete for a variety of awards using the usual amateur bands of 80, 40, 20, 15, 10, 6 and 2 meters. For further information, go to <http://parks.portcars.org>.

(This was sent to KC8COT and is felt to make a lot of sense in making a weather net more efficient and effective.)

A survey was conducted on the air last night to find ways to improve our nets. Below is a list of tips in no particular order. I am sure there are others, but these include our biggest problems.

1. Do not file rain reports . (unless catastrophic)
2. Turn on "Net" courtesy tone when in directed net mode.
3. NCS should do H&W checks periodically. This means that if you haven't checked out, you are expected to respond when called.
4. Use enough transmitter power. Unless you are within a mile or so of the repeater, you won't get in with a HT when lightning is in the vicinity.
5. Use the correct repeater input for your location.
6. Investigate linking the local repeaters during the net.
7. Follow established criteria for reporting.
8. Have a valid amateur radio callsign.
9. Keep reports brief and simple. Think about what your are going to say before keying the microphone.
10. Don't forget to check in and out of the net.
11. Use a second radio (when possible) to monitor the quality of your signal into the repeater.
12. Don't cut yourself off by speaking too soon after keying your microphone.
13. Speak loudly and clearly. We have received many "weak audio" reports lately.
14. Don't announce every weather bulletin on the net. Usually Net Control already has this information and decides what to do with it.
15. Don't bother to report downed trees during a warning. Then only report trees that are completely blocking major roads. The only exception would be if it appears that a tornado or downburst has just occurred.
16. This is a Kalamazoo County net. As such, we are not interested in reports from other counties unless it will have an immediate and severe impact on Kalamazoo County. (i.e. Tornado, Macrobust, Derecho)

The net should be a quiet time, with stations only reporting severe events or when queried by the Net Control station.

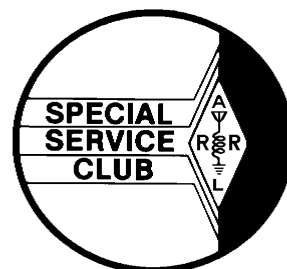
